### Holiday Fairs move to Moncks Corner Regional Recreation Complex

We have some exciting news to share this year. While Celebrate The Season's Holiday Lights Driving Tour will continue its path from Santee Cooper's entrance through Old Santee Canal Park, the weekend Holiday Fairs will be moving to the Town of Moncks Corner's Regional Recreation Complex on Main Street.

This year, the Holiday Fairs begin on Saturday, Dec. 2, during the Moncks Corner Christmas Parade and Tree Lighting, which starts at 6 p.m. and features the S.C. State Marching Band. The Holiday Fairs will feature Santa Claus, live entertainment, children's rides, marshmallow roasts, food and drinks, and more.

Because of its popularity, the festival outgrew the grounds at Old Santee Canal Park. The Town of Moncks Corner is keeping spirits bright by hosting the Holiday Fairs. This truly is a community-wide event!

Admission continues to be \$5 per vehicle and gate proceeds will benefit charities serving Berkeley County. Since 2011, Celebrate The Season has donated \$712,700 to local charities.

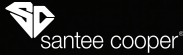

## 2017 HOLIDAY FAIR VENDOR RULES

Spaces are limited to first applications received.  
A waiting list will be maintained.

No food items may be sold for consumption  
at the complex. Other spaces are available for  
concessions for nonprofit 501(c)(3) organizations.

Set up may begin as early as 9 a.m. on Dec. 2, unloading  
must conclude by 4:30 p.m.

Vendors can park in parking lots. Vehicles will not be  
permitted inside the gates of the complex.

There will be some walking involved to get  
to your designated space. Dollies, hand trucks,  
and/or wagons may be helpful.

The ground (grass) may be uneven, plan accordingly by  
bringing risers or adjustable stands.

All crafters are required to have a solid white,  
green, or tan roofed tent (10 ft. x 10 ft.).

Exhibitors are expected to cover their tables  
with table coverings touching the ground  
to hide boxes or craft materials.

Exhibitors must keep their wares  
within their assigned space.

No lighting or power cords will be furnished,  
however outlets will be available for use.

Electric heaters are prohibited.  
Propane heaters are acceptable.

No exhibitor may tear down their booth until  
the complex has closed for the evening.

**Notification of application acceptance/  
non-acceptance will be mailed on or before Nov. 10.  
The booth fees will be due by Friday, Nov. 17.**

*If fees are not received by then, the booth will be filled  
with the next applicant on the waiting list.*

*Refunds will only be available with a written notice provided  
within five working days of the event.*

Holiday Fair passes will be distributed at check-in.

Two will be provided for each booth and  
are good for the whole month.

Lost passes can be replaced for \$5.

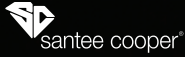
Each exhibitor is responsible for the collection,
